I am personally very pleased to announce a big congratulations to Doug Young in acquiring what will be known very simply as an "Impromptu Event" through the current Queensland Restricted Vehicle Registration System (see QHMC Bulletin 2018-1 – Doug's Report for further information).

On becoming QHMC president 2017/18 and bringing Doug Young in as the QTMR MOCC Delegate in which both Doug and I attended all QTMR meetings with the above in mind.

My feelings were confirmed by Val Sharp (Vice President and former President of QHMC) that Doug Young was the most valuable person to have as the QTMR Delegate.

This was my personal President's Tenure to give Doug a free hand with guidelines to work within the system we had without changing our current system. His successful achievement within these guidelines will not detract from the current Queensland Restricted Vehicle Registration System and will not put anyone at a disadvantage, with no extra cost to current vehicle registration fees, no extra paperwork (i.e. logbook or similar) and no additional rules – "Made Simple and Easy!" This goes to the credit of Doug's achievements given this has been a very long and unsuccessful battle for past committees.

We have succeeded in the change of wording as an "Impromptu Event", basically, this may be for one or more vehicles within Queensland's current Restricted Vehicle Registration System.

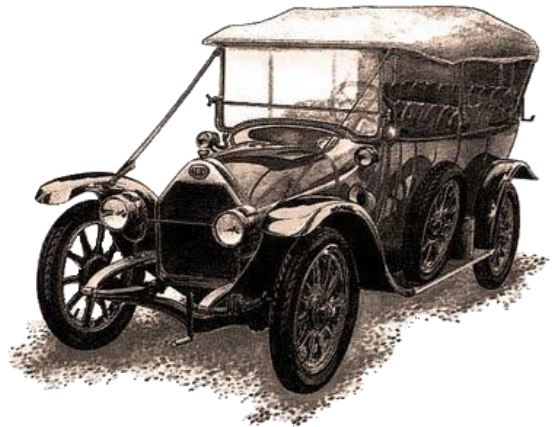

## OBJECTIVES OF THE QHMC

The Objectives of the QHMC are to:

- Foster interest in the history and preservation of old vehicles, as owned by members of affiliated clubs;
- Act on behalf of clubs and/or individual members in negotiations with Federal, State or Local Government, Authorities, Companies, Corporations, or individuals, on matters of interest to the hobby;
- Keep an up to date list of projected rally dates, in order to assist the clubs to avoid clashing dates, and to attempt to ensure maximum support of all major events by whatever means may be suitable, through the promotion of maximum co-operation between affiliated clubs;
- Act a liaison body between the hobby and the general public;
- Cooperate and liaise with any other similar State or Federal organisations;
- Circulate any information concerning or affecting the development of clubs within the Association's geographical area, which the Association may consider will promote the objects of affiliated clubs.
