Trevor Beutel Declared the meeting open at: 7.35 p.m. and welcomed all and thanked all for their attendance.

President advised the Delegates that Doug Young would be addressing the Meeting in relation to Impromptu Events. After five minutes the Secretary asked for Meeting to stop as there were many visitors present.

7.40P.M. – 8.55 P.M. Impromptu Events were discussed and explained and methods for recording by Doug Young, for the next 75 minutes and questions were taken from the floor. Questions from John Hogg, Lachlan Pierce, Carle Gregory, John Green, Laurie Bennett, Alec Connors, Laurie Pugsley, Glen Tucker, Dave Carmichael, Doug Murphy. Most of the points raised are in the Bulletin on the website which has been forwarded to the Club Delegates and Affiliated Clubs. The General points and responses were as follows:

Whereas the Log Book system was never likely to be considered by T.M.R. Doug Young approached TMR about having a scheme similar to W.A. which allows Club Runs, Parades, Road testing etc. Their scheme also allows individual club members to organise a club run at short notice where they are called "Single Vehicle Events". Doug approached TMR who have now agreed to Old. members having "Impromptu Events" "on a case by case basis as long as the event is added to the Incorporated Club's newsletter, Website or Social media page." ("In W.A. Club's effect this by

- 1. Sending an email to the Club which is placed on the website.
- 2. Filling in an on-line form which results in it becoming a listed event automatically.")

Doug found out about this and made representations to TMR about it. TMR has now agreed to having "Impromptu Events" here in Qld. T.M.R. acknowledge it can be for "one or more" vehicles. "This will give many of the benefits over a Log Book scheme without the restrictions and administrative burdens Log Books create for the member, club officials and Government. It is up to individual clubs whether they want to participate in the scheme or not, and how they implement it.

In relation to Social media Doug also acknowledged many members don't use Facebook/participate in Social media and Impromptu Events needed to be "logged" or recorded within the club Log Book or similar system and the member holding the event has some evidence of the event being lodged prior to the event in case they were questioned by police/law enforcement. Such as an email. Impromptu events have never been legislated for SIVS vehicles, it is a Policy. Email from TMR is on the Q.H.M.C. website in the Bulletins section. Next TMR Meeting is in March 2019 when Liaison Officers will ask for Impromptu events to be included on TMR webpage.

Delegate Glen asked if SIVS vehicles could still be used on interstate events.

D.Y. Yes, current SIVS scheme still applies.

(Drivers are to carry application form/flyer about the event with them).

Please do NOT contact TMR Doug Young will draft an article to go on SIVS page.

If Social media is not available phone or contact Club person who is recording the event. The Club must have a record of the event.

Another Delegate asked if a Club has to be incorporated to hold an Impromptu Event.

D.Y. Yes, a Club must be incorporated with the Office of Fair Trading.

Doug Young stated he was surprised that TMR accepted the proposal and they have the mindset of not wishing to become too involved. He also stated that T.M.R. would be watching this carefully, that this is a great privilege and not to be abused.

SIVS registered vehicle cannot be used for commuting to and from work, as a work vehicle of for hire/reward, Insurance MAY be voided if an accident occurred and Insurers look for ways to avoid liability.

Members are encouraged to carefully read the Bulletin under TMR section dated 21ast November 2018 which explains "impromptu Events".

Karen Dawes, the Facebook contact from Roma spoke on-line about Facebook, explained and discussed various types of Facebook, i.e. Group Page, Open/ Closed Group and other options. David Barnett asked why Queensland can't have a SIVS scheme similar to Tasmania with a Log Book. Response was TMR do not want Log Books.

Frank and Warren O'Donnell from Townsville Veteran Vintage and Historic Motor Club and Karen Dawes (Roma) took part in a Conference call during the talk.

Secretary thanked those present for their patience and attendance. Also thanked Doug Young for his informative talk which was appreciated.

At 8.50p.m. the Meeting returned to its normal protocol.

SECRETARIES REPORT:

Minutes of Previous General Meeting 22nd November 2018: prior to Meeting distributed to delegates as and on the QHMC website. Cheryl Nott asked for any corrections.

Delegate Albert Budworth responded the November Minutes were not correct. He asked of those present who had read the 33 pages? No response.

Delegate Sharon Auld stated there were items brought up during the Meeting which weren't in the Minutes. In relation to Treasurers Report:

- Unknown cheques: Christine Stevens during her response suggested what the payments were
 for payment of Hall costs. Christine Stevens stated she was not a committee person/Treasurer
 during that period and queries would need to be addressed by the current
 Committee/Treasurer.
- 2. Christine Stevens spoke at length and defended herself against accusations made.

- 3. She explained in relation to the Tasmania Tour that she and Greg were personally out of pocket over \$2800 and all of the \$5100 donated by Tas Events had been spent within Tasmania in accordance to the directives of Tas Events.
- 4. Christine responded to questions about a "Grant" from Ipswich City Council for Motoring Heritage Day 2017. No Grant was applied for and No Grant was received.
- 5. Christine Stevens advised that documents/Fixed Assets register were handed to Trevor Beutel after the 2017 A.G.M. Two Delegates, namely Tom Lewis and Gavin Mc Hugh confirmed this stating they were present when this occurred. President denied receiving it. Neither Christine's statement nor the confirmation of the two Delegates has been included within the Minutes. These statements need to be included in Minutes.
- 6. T.M.R. Report: Much of the Report doesn't make sense.
- 7. One of the Delegates present stated that the Executive should be left to sort out any Fair Trading/legal requirements and "a line should be drawn under further discussion". A second Delegate re-iterated these sentiments. Not recorded in Minutes.

Secretary advised the Meeting the current Cheque Book is missing, and it was guesswork who the Cheques were in favour of as payee details are not recorded on bank statements. All the foregoing was in the Attachments to the November Minutes.
