APPOINTMENT OF THE AUDITOR Cheryl Nott advised and wish to stay with the same Auditor and explained the situation. Cheryl Nott moved the motion that Jorgensen & Associates Pty Ltd of Tingalpa be Q.H.M.C.Inc. Auditor for 2020-2021 Seconded by Henry Hancock. All in favour, Nil Against Carried.

Cheryl Nott then asked for approval, and ratified the payment to the Office of Fair Trading \$56.60. Seconded by Albert Budworth All in favour Nil Against, Carried.

**GENERAL BUSINESS** Cheryl Nott advised that a sign was on the Office of Fair Trading Form stating New Laws check our website but the committee was already doing this. As discussed in the General Meeting tonight Chapter11 be added to the Constitution and other changes the President stated, needed to be approved and ratified at the Annual General Meeting before going to the Office of Fair Trading. Moved by Chris Pike, Seconded by Albert Budworth, All in favour Nil Against Carried. The By-Laws need to be approved and ratified also Moved by Rod Roberts Seconded by Doug Murphy. All in favour Nil Against Carried.

A Record of Q.H.M.C.Inc. of Assets and Inventory have been compiled and will be reviewed annually prior to the annual, A.G.M. Carle Gregory, President added that this was a recommendation from Rod Graydon.
